Graduate Student Services Committee - Summary of Service/Fee Options

All options entail:

- equal access to SWC and A&R for graduate and undergraduate students.
- grad student representation on the McMaster's Student Services Committee (SSC) and subcommittees.
- phase in over a three year period between Fall 2016 and Fall 2018.

Any charges recovered by SWC through the GSA Health Plan will be used to offset fees in the following year (rough est. \$50K/year).

Option A - Base Level

No additions to mental health services for graduate students; no School of Graduate Studies career services fee

Option B - Base Level + Career Services

Add SGS Career Services fee to option A

The SGS career services fee would enable SGS to make the Career Strategist position permanent and would enable SGS to hire another position specializing in Career Services for graduate students.

Option C - Career Services + additional mental health support

Additional mental health support entails a dedicated graduate student counsellor who would improve continuity of care through

summer months, and access to counsellors for partners of graduate students.
